Suggested clause for an unrestricted gift:

I give the sum of ___ dollars to the St. Thomas Elgin General Hospital Foundation to be used for its general purposes as the St. Thomas Elgin General Hospital Foundation sees fit.

Suggested clause for unrestricted use gift of residue:

I give the residue (OR ___% of the residue) of my estate to the St. Thomas Elgin General Hospital Foundation to be used for its general purposes as the St. Thomas Elgin General Hospital Foundation sees fit.

Suggested clause for a restricted gift:

I give the sum of ___ dollars to the St. Thomas Elgin General Hospital Foundation to be used for ___. If unforeseen circumstances make the specified use of this gift no longer practical or desirable as determined by the St. Thomas Elgin General Hospital Foundation, the St. Thomas Elgin General Hospital Foundation may change the terms of the specified use, such change to be in keeping as far as possible with the general intent of this gift.

Suggested clause for restricted use of a residuary gift:

I give the residue (OR ___% of the residue) of my estate to the St. Thomas Elgin General Hospital Foundation, to be used for ___. If unforeseen circumstances make the specified use of this gift no longer practical or desirable as determined by the St. Thomas Elgin General Hospital Foundation, the St. Thomas Elgin General Hospital Foundation may change the terms of the specified use, such change to be in keeping as far as possible with the general intent of this gift.

Suggested clause for a gift of a specific sum with naming provision:
